

The journal is peer-reviewed (at least two reviewers for each article), with open access (access completely free of charge for anyone interested), currently with no cost for publication of articles (however, the articles, besides being valid from the scientific standpoint, must also be written in proper English or Italian).

PUBLISHER'S ROLE. Publisher shall be solely responsible for all editorial, design, publishing and marketing decisions and all costs related to the editorial production and administration of the Journal in all media including but not limited to the following activities:

- a. layout, design, style, form, titles, composition, manufacture, production, format and pricing;
- b. frequency of publication with a minimum of producing at least two (2) issues per volume year;
- marketing, advertising, licensing, sales and distribution; c.
- in consideration of the action of JPNIM in reviewing and editing the submissions, the assignment of copyright is totally free of charge and final in favor of the JPNIM Publisher – it being acknowledged the sole right of paternity to the authors;
- to note the official affiliation to the Society on JPNIM website and in publicity material developed for the Journal;
- if the Society will decide to publish the Proceeding of its Congresses and Meetings or other kind of publications (to be published

in a special section of the Journal, dedicated to the Society activity), the Publisher will offer an economic proposal (not binding) to the Society, for publication (in electronic format). All materials to be published have to be provided in good English or Italian. Thanks to this agreement, if JPNIM will serve as Official Journal of the Society, regular publication prices will be subject to a 20% discount.

- g. Publisher shall not be responsible for delays in publication caused by circumstances beyond its control;
- h. Publisher shall be free to stipulate other similar agreements with other scientific, cultural, humanitarian societies.

**SOCIETY'S ROLE.** The Journal shall serve as the **Official Journal** of the Society. This affiliation shall be noted in the Journal issues and in all related publicity materials. The society shall be responsible for the following activities:

- a. prominently post information about the Journal on the Society website including a web link to the Journal website;
- b. regularly publicize the Journal to the Society members via the Society's website and/or newsletter;
- c. with the respect to any contribution made to the Journal, grant the Publisher copyright to the work;
- d. hereby grant to the Publisher the right to use the Society's name and logo (if appropriate) in connection with promotion/marketing of the Journal:
- e. provide the Publisher the option to receive complimentary display space where available at the Society's conferences to promote the Journal and related titles to members;
- f. appointing an officer to liaise with the Publisher on all the workings of this Agreement.

**APPLICABLE LAW, JURISDICTION AND COMPETENCE IN CASE OF DISPUTE.** Italian legislation shall be applied, and it is agreed that the place of jurisdiction and competence in any controversy that may arise is Verona, Italy.

**CONFIDENTIALITY.** The Society and Publisher agree not to divulge, disseminate or publicize the terms of this Agreement to any third party, except as may be required by law.

**TERM AND TERMINATION.** This Agreement is without term.
